- 3 The Company is a public company limited by shares.
- 4 The liability of the members is limited to the amount, if any, unpaid on the shares held by them.
- 5 Nothing in these Articles shall constitute a restriction on the objects of the Company to do (or omit to do) any act and, in accordance with section 31(1) of the CA 2006, the

Business

6 Any branch or kind of business which the Company is either expressly or by implication authorised to undertake may be undertaken by the Directors at such times as they think fit, and may be permitted by them to be in abeyance, whether the branch or kind of business commenced or not, so long as the Directors deem it expedient not to commence or proceed with it.

Registered office

7 The Office shall be at such place in England or Wales as the Directors appoint.

Capital

8 At the date of these Articles the capital of the Company is divided into the following classes of shares: ordinary shares of £1 each ("**Ordinary Shares**"); "B" Deferred Shares of 10p each; and "C" Deferred Shares of 1p each, each such class shall confer upon the holders thereof the rights, and be subject to the restrictions as are set out in this article 8.

8.1 The "B" Deferred Shares (the "**B**" Deferred Shares") shall have a nominal value of 10p (ten pence) and shall confer upon the holders thereof the rights, and be subject to the restrictions, as follows:

8.1.1 Income

The "B" Deferred Shares shall not confer any right to participate in any profits of the Company.

8.1.2 Capital

On a winding up or other return of capital each "B" Deferred Share shall entitle the holder thereof the right to receive the nominal value thereof if and only if the holders of Ordinary Shares in the capital of the Company have received the sum of £1,000,000 (One Million Pounds Sterling) per Ordinary Share.

8.1.3 Voting

The "B" Deferred Shares shall not confer upon the holders thereof the right to receive notice of or attend or vote at any general meeting of the Company.

8.1.4 Cancellation of "B" Deferred Shares

The following provisions shall apply to the "B" Deferred Shares:

8.1.4.1 The Company shall have irrevocable authority to appoint any person to execute on behalf of the holders of the "B" Deferred Shares a transfer/cancellation of the "B" Deferred Shares and/or an agreement to transfer/cancel the same, without making any payment to the holders of the "B" Deferred Shares to such person or persons as the Company may determine as custodian thereof and, pending such transfer and/or cancellation and/or purchase, to retain the certificate for such shares. The Company may, at its option at any time purchase all or any of the "B" Deferred Shares then in issue, at a price not exceeding one penny for all the "B" Deferred Shares so purchased or may cancel such shares by way of reduction of capital for no consideration.

8.1.4.2 Neither the passing by the Company of any resolution for the cancellation of the "B" Deferred Shares for no consideration by means of a reduction of capital requiring the confirmation of the Court nor the obtaining by the Company nor the making by the Court of any order confirming any such reduction of capital nor the becoming effective of any such order shall constitute a variation, modification or abrogation of the rights attaching to the "B" Deferred Shares and accordingly the "B" Deferred Shares may at any time be cancelled for no consideration by means of a reduction of capital effected in accordance with the Acts without sanction on the part of the holders of the "B" Deferred Shares.

8.2 The "C" Deferred Shares (the "**C**" Deferred Shares") shall have a nominal value of 1p (one pence) and shall confer upon the holders thereof the rights, and be subject to the restrictions, as follows:

8.2.4.2 any increase or reduction or subdivision or other alteration in the authorised or issued share capital of the company shall be deemed not to be a variation or abrogation of the rights attaching to the "C" Deferred Shares;

8.2.4.3 the Company shall have irrevocable authority to appoint any person to execute on behalf of the holders of the "C" Deferred Shares a transfer/cancellation of the "C" Deferred Shares and/or an agreement to transfer/cancel the same, without making any payment or otherwise providing any valuable consideration to the holders of the "C" Deferred Shares to such person or persons as the Company may determine as custodian thereof and, pending such transfer and/or cancellation, to retain the certificates for such shares. The Company may, at its option at any time purchase all or any of the "C" Deferred Shares then in issue in accordance with the provisions of the Companies Act 2006, without making any payment to the holders thereof or otherwise providing any valuable consideration. Subject thereto the "C" Deferred Shares shall not be transferable.

9 Subject to these Articles and the Statutes but without prejudice to any special rights previously conferred on the holders of any shares or class of shares already issued (which special rights shall not be modified or abrogated except with such consent or sanction as is provided in the next following article), a share may be issued with such preferred, deferred or other special rights or such restrictions, whether in regard to dividend, return of capital, voting or otherwise, as the Company by ordinary resolution determines or, if no such resolution is in effect or so far as the resolution does not make provision, as the Board may decide.

If the Company destroys a document in good faith and without notice of any claim (regardless of the parties) to which the document might be relevant, it shall conclusively be presumed in favour of the Company that every instrument of transfer so destroyed was a valid and effective instrument duly and properly registered, every share certificate so destroyed was a valid and effective document duly and properly cancelled and every other document mentioned above so destroyed was a valid and effective document in accordance with the recorded particulars in the books or records of the Company. Nothing in this article shall be construed as imposing upon the Company any liability in respect of the destruction of any document at an earlier date than that provided above or

- 79 A member, in respect of whom an order has been made by a competent court or official on the ground that he is or may be suffering from mental disorder or is otherwise incapable of managing his affairs, may vote, whether on a show of hands or on a poll, by any person authorised to do so on his behalf and that person may on a show of hands or on a poll vote by proxy, provided that such evidence as the Directors require of his authority has been deposited at the Office not less than 48 hours before the time for holding the meeting.
- 80 No member shall be entitled to vote at any general meeting either personally or by proxy, or to exercise any privilege as a member, unless all calls or other sums presently payable by him in respect of shares in the Company have been paid.
- 81 A member holding unclassified shares shall be entitled to vote at any general meeting in respect of those shares, provided that no ordinary share is in issue.
- 82 No objection shall be raised to the qualification of any vote except at the meeting or adjourned meeting at which the vote objected to is given or tendered. Every vote not disallowed at the meeting shall be valid for all purposes. An objection made in due time shall be referred to the Chairman whose decision shall be final and shall be conclusive.
- 83 On a poll votes may be given either personally or by proxy.
- 84 Subject to article 89, the instrument appointing a proxy must be In Writing in any usual or common form or in any other form which the Directors may approve under the hand of the appointor or of his attorney duly authorised In Writing, or if the appointor is a corporation either under its common seal or under the hand of an officer or attorney so authorised. The Directors may, but shall not be bound to, require evidence of the authority of the officer or attorney. A proxy need not be a member of the Company and a member may appoint more than one proxy in relation to a meeting provided that each proxy is appointed to exercise the rights attached to a different share or shares held by him. If the Directors in their discretion so decide, a proxy appointment may be sent in Electronic Form or by Electronic Means, subject to authentication in such manner as the Directors may determine.
- 85 A proxy appointment which is sent in Electronic Form or by Electronic Means must be received at an address specified by the Company for the purpose of receiving such

communications:

- 85.1 in (or by way of a note to) the notice convening the meeting; or
- 85.2 in any form of proxy appointment sent out by the Company; or
- 85.3 in any invitation contained in Electronic Form or by Electronic Means to appoint a proxy issued by the Company;

in each case not less than 48 hours (subject to section 327(2) CA 2006) before the time of the meeting or adjourned meeting at which the person named in the proxy form proposes to vote.

- 86 A corporation holding shares conferring the right to vote may, by resolution of its directors or other governing body, authorise any one or more of its officials or any other person or persons to act as its representative(s) at any meeting of the Company or at any meeting of holders of any class of shares of the Company. Subject to any arrangements put in place at general meetings by the Company (to the extent permitted) the authorised representative or representatives shall be entitled to exercise the same powers on behalf of the corporation which he or they represent as if he or they had been an individual member of the Company.
- 87 Failing previous registration with the Company, the instrument appointing a proxy and the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of the power or authority, must be deposited, not less than 48 hours (subject to section 327(2) CA 2006) before the time appointed for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote, at the Office or at such other place as is nominated by the Board. In default the instrument of proxy shall not be treated as valid.
- 88 An instrument of proxy must be in a common form or form which the Directors approve. Proxies need not be witnessed. The proxy shall be deemed to include the right to demand or join in demanding a poll and generally to act at the meeting for the member giving the proxy. The proxy shall, unless it states the contrary, be valid for an adjournment of the meeting as well as for the meeting to which it relates.
- 89 The Board may decide, at its sole discretion, either generally or in any particular case, to treat an instrument of proxy as properly deposited for the purposes of this article if a copy of the instrument is delivered in Electronic Form, in any case, to an address (including an Electronic Address) specified for the receipt of such documents and appointments in Electronic Form in the notice convening the meeting or in any instrument of proxy set out by the Company in relation to the meeting or at such other address as is agreed by the Board from time to time. This power is subject to any limitations, restrictions or conditions that the Board may decide. Any requirements of these articles, which are inconsistent with this method of appointment, shall not apply to appointments under this power. The Board can require such evidence as it thinks appropriate to show that the proxy appointment is genuine. If two or more valid but

differing appointments of a proxy are delivered or (in the case of appointments in Electronic Form) received in accordance with article 86 in respect of the same share for use at the same meeting, the one which is last delivered or, as the case may be, received as aforesaid (regardless of its date, its date of sending or the date of its execution) shall be treated as replacing and revoking the others as regards that share. If the Company is unable to determine which was delivered or received last, none of them shall be treated as valid in respect of that share.

- 90 A vote given in accordance with the terms of an instrument of proxy shall be valid, notwithstanding the previous death or incapacity of the principal or revocation of the proxy, or of the authority under which the proxy was executed, or the transfer of the share in respect of which the proxy is given, provided that no intimation In Writing of the death, incapacity, revocation or transfer has been received at the Office at least 48 hours before the commencement of the meeting or adjourned meeting at which the proxy is used.
- 91 If a member, or a person appearing to be interested in shares held by a member, has been duly served with a notice under section 793 CA 2006 ("**statutory notice**") and is in default for the prescribed period in supplying to the Company the required information or makes a statement which in the opinion of the Board is false or misleading in any material particular, then not earlier than 28 days or such less number of days as may be permitted from time to time by the London Stock Exchange, [the Financial Services Authority or such other relevant regulatory authority](#), after service of the statutory notice, the Directors may at any time, by notice ("**direction notice**") to the member, direct that in respect of the shares in relation to which the default occurred ("**default shares**") the member is not entitled to vote, either personally or by proxy, at a general meeting or a meeting of the holders of any class of shares of the Company or to exercise any other right conferred by membership in relation to general meetings of the holders of any class of shares of the Company.
- 91.1 Where the default shares represent at least 0.25 per cent of the issued shares of a class, the direction notice may additionally direct:
- 91.1.1 that any dividend or other money which would otherwise be payable in respect of each of the default shares shall (in whole or part) be retained by the Company without any liability to pay interest when the dividend or money is paid to the member;
- 91.1.2 that no transfer of the default shares which is not an approved transfer shall be registered unless:
- 91.1.2.1 the member is not himself in default as regards supplying the information required; and
- 91.1.2.2 the transfer is of part only of the member's holding and, when presented for registration, is accompanied by a certificate by the member in a form satisfactory to the Directors to the effect that,

after due and careful enquiry, the member is satisfied that none of the shares the subject of the transfer is a default share.

| 91.2 The Company shall send a copy of the notice to each other person appearing to be interested in the shares the subject of a direction notice but the failure or omission by the Company to do so shall not invalidate the notice.

| 91.3 A direction notice shall have effect in accordance with its terms for so long as the default in respect of which it was issued continues and (unless the direction notice otherwise determine) for a further period of one week but shall cease to have effect in relation to any default shares which are transferred by the member by means of an approved transfer.

| 91.4 For the purpose of this article:

| 91.4.1 a person shall be treated as appearing to be interested in shares if the member holding the shares has given to the Company a notification under section 793 CA 2006 which either (a) names that person as being interested; or (b) fails to establish the identities of those interested in the shares and (after taking into account the notification and any other relevant section 793 CA 2006 notification) the Company knows or has reasonable cause to believe that the person in question is or may be interested in the shares;

| 91.4.1.1 the prescribed period is 14 days from the date of service of the notice under section 793 CA 2006; and

| 91.4.1.2 a transfer of shares is an approved transfer if:

| 91.4.1.2.1 it is a transfer of shares to an offeror by way or in pursuance of acceptance of a take-over offer for a company (~~for the purposes of the City Code on Takeovers and Mergers~~); or

| 91.4.1.2.3 the transfer results from a sale made through a recognised investment exchange ~~within the meaning of Part 18 of the Financial Services and Markets Act 2000~~ or any other stock exchange outside the United Kingdom on which the Company's shares are normally traded.

| 91.5 Nothing contained in this article shall limit the power of the Directors under section 794

CA 2006.

Directors

- 92 Unless otherwise determined by ordinary resolution, the number of Directors (other than the alternate directors) shall not be subject to a maximum but shall not be less than three.
- 93 The Directors shall be paid out of the funds of the Company by way of remuneration for their services such sums as the Company by ordinary resolution determine. The remuneration shall be divided among them in such proportions and manner as the Directors determine and, in default of a determination within a reasonable period, equally, except that any Director holding office for less than a year or other period for which remuneration is paid shall rank in the division in proportion to the fraction of the year or other period during which he has held office. The remuneration shall be deemed to accrue from day to day. The Directors may also be paid all travelling, hotel and other expenses properly incurred by them in attending and returning from meetings of the Directors or committees of the Directors or general meetings of the Company or in connection with the business of the Company.
- 94 Subject to the provisions of these Articles and without prejudice to the powers of the Directors under these Articles to appoint any person to be a Director, the Company may by ordinary resolution elect any person to be a Director, either to fill a casual vacancy or as an addition to the existing Board, but the total number of Directors must not at any time exceed any maximum number fixed by or in accordance with these Articles.
- 95 Any Director who at the request of the Board performs special services or goes or resides abroad for any purposes of the Company may (unless otherwise expressly resolved by the Company in general meeting) receive such extra remuneration by way of salary, percentage of profits or otherwise as the Board determines.
- 96 No shareholding qualification for Directors is required.
- 97 Each Director may attend and speak at any annual general meeting and any general meeting of the Company.
- 98 The office of a Director shall be vacated in any of the following events, namely:
- 98.1 if (not being an executive Director whose contract precludes resignation) he resigns his office by notice In Writing left at the Office;
- 98.2 if he becomes bankrupt or has a receiving order made against him or compounds with his creditors;
- 98.3 if he becomes of unsound mind or a patient for any purpose of any statute relating to mental [or physical](#) health and the Directors resolve that his office should be vacated;
- 98.4 if he is absent from meetings of the Directors for 6 months without leave, and his

alternate Director (if any) does not during that period attend in his stead, and the Directors resolve that his office should be vacated;

- 98.5 if he is removed or becomes prohibited from being a Director under any provision of the Statutes;
- 98.6 if he is requested In Writing by all the other Directors to resign his office.
- 99 A Director may hold any other office or place of profit with the Company (except that of Auditor) in conjunction with his office of Director for such period and upon such terms as the Board determines, and may be paid such extra remuneration for it (whether by way of salary, commission, participation in profits or otherwise) as the Board determines. The extra remuneration shall be in addition to any remuneration provided for by or pursuant to any other article.
- 100 A Director may act by himself or his firm in a professional capacity for the Company (otherwise than as Auditor) and he or his firm shall be entitled to remuneration for professional services as if he were not a Director.
- 101 A Director may be or become a director or other officer of, or otherwise interested in, a company promoted by the Company or in which the Company is interested, and shall not be liable to account to the Company or the members for any remuneration, profit or other benefit received by him as a director or officer of or from his interest in that company. The Board may cause the voting power conferred by the shares in another company held or owned by the Company to be exercised in such manner as it thinks fit, including the exercise in favour of a resolution appointing any of the Directors to be directors or officers of that company, or voting or providing for the payment of remuneration to the directors or officers of that company.
- 102 A Director shall not vote or be counted in the quorum on a resolution of the Board concerning his own appointment as the holder of an office or place of profit with the Company or another company in which the Company is interested (including the arrangement or variation of its terms or its termination).
- 103 Where arrangements are under consideration concerning the appointment (including the arrangement or variation of the terms or the termination of the appointment) of two or more Directors to offices or places of profit with the Company or another company in which the Company is interested, a separate resolution may be put in relation to each Director. In such case, each of the Directors concerned shall be entitled to vote (and be counted in the quorum) in respect of each resolution except that concerning his own appointment (or the arrangement or variation of its terms or its termination) and except (in the case of an office or place of profit with another company) where the other company is a company in which the Director owns 1 per cent or more.
- 104 Subject to the Statutes and to the next paragraph of this article, no Director or proposed or intending Director shall be disqualified by his office from contracting with the Company, either with regard to his tenure of any office or place of profit or as vendor or

purchaser or in any other manner. No contract or arrangement in which a Director is interested shall be liable to be avoided. The Director shall not be liable to account to the Company or the members for any remuneration, profit or other benefits realised by the contract or arrangement by reason of his holding that office or of the resulting fiduciary relationship.

- 105 A Director who to his knowledge is interested, whether directly or indirectly, in a contract or arrangement or proposed contract or arrangement with the Company must declare the nature of his interest at the meeting of the Board at which the question of entering into the contract or arrangement is first taken into consideration, if he knows his interest then exists, or, in any other case, at the first meeting of the Board after he knows that he is or has become interested. A general notice to the Board given by a Director to the effect that he is a member of a specified company or firm and is to be regarded as interested in any contract or arrangement which may after the date of the notice be made with the company or firm shall be a sufficient declaration of interest under this article in relation to any contract or arrangement made with the company or firm. A notice shall not be effective unless either it is given at a meeting of the Board or the Director giving it takes reasonable steps to secure that it is brought up and read at the next Board meeting after it is given.
- 106 For the purposes of section 175 CA 2006, the Board may authorise any matter proposed to it in accordance with these Articles which would, if not so authorised, involve a breach of duty by a Director under that section, including, without limitation, any matter which relates to a situation in which a Director has, or can have, an interest which conflicts, or possibly may conflict, with the interests of the Company.
- 106.1 Any such authorisation will be effective only if:
- 106.1.1 any requirement as to quorum at the meeting at which the matter is considered is met without counting the Director in question or any other interested Director; and
 - 106.1.2 the matter was agreed to without their voting or would have been agreed to if their votes had not been counted.
- 106.2 The Board may (whether at the time of the giving of the authorisation or subsequently) make any such authorisation subject to any limits or conditions it expressly imposes but such authorisation is otherwise given to the fullest extent permitted.
- 106.3 The Board may vary or terminate any such authorisation at any time.
- 106.4 For the purposes of these Articles, a conflict of interest includes a conflict of interest and duty and a conflict of duties, and interest includes both direct and indirect interests.
- 106.5 Subject to sections 177(5) and 177(6) CA 2006, provided that he has disclosed to the Board the nature and extent of his interest, a Director notwithstanding his office:

106.5.1 may be a party to, or otherwise interested in, any transaction or arrangement with the Company or in which the Company is otherwise (directly or indirectly) interested;

106.5.2 may act by himself or his firm in a professional capacity for the Company (otherwise than as auditor) and he or his firm shall be entitled to remuneration for professional services as if he were not a Director;

106.5.3 may be a director or other officer of, or employed by, or a party to a transaction or arrangement with, or otherwise interested in, any body corporate in which the Company is otherwise (directly or indirectly) interested.

107 A Director shall not, by reason of his office, be accountable to the Company for any remuneration or other benefit which he derives from any office or employment or from any transaction or arrangement or from any interest in any body corporate:

107.1 the acceptance, entry into or existence of which has been approved by the Board pursuant to article 107 (subject, in any such case, to any limits or conditions to which such approval was subject); or

107.2 which he is permitted to hold or enter into by virtue of articles 106.5.1 to 106.5.3 above; nor shall the receipt of any such remuneration or other benefit constitute a breach of his duty under section 176 CA 2006.

108 Any disclosure required by article 106.5 may be made at a meeting of the Board, by notice in writing or by general notice or otherwise in accordance with section 177 CA 2006.

109 A Director shall be under no duty to the Company with respect to any information which he obtains or has obtained otherwise than as a Director of the Company and in respect of which he owes a duty of confidentiality to another person. However, to the extent that his relationship with that other person gives rise to a conflict of interest or possible conflict of interest, this article applies only if the existence of that relationship has been approved by the Board pursuant to article 106. In particular, the Director shall not be in breach of the general duties he owes to the Company by virtue of sections 171 to 177 CA 2006 because he fails:

- 110.2 makes arrangements not to receive documents and information relating to any matter which gives rise to the conflict of interest or possible conflict of interest sent or supplied by the Company and/or for such documents and information to be received and read by a professional adviser; for so long as he reasonably believes such conflict of interest or possible conflict of interest subsists.
- | 111 The provisions of articles ~~109~~ and ~~110~~ are without prejudice to any equitable principle or rule of law which may excuse the Director from:
 - 111.1.1 disclosing information, in circumstances where disclosure would otherwise be required under these articles; or
 - | 111.1.2 attending meetings or discussions or receiving documents and information as referred to in article ~~110~~, in circumstances where such attendance or receiving such documents and information would otherwise be required under these articles.
- 112 Except as otherwise provided by these Articles, a Director must not vote on (or be counted in the quorum in respect of) any resolution of the Board concerning a contract or arrangement or other proposal which (together with any interest of any person connected to him) is to his knowledge, directly or indirectly, a material interest otherwise than by virtue of his interests in shares or debentures or other securities of, or otherwise through, the Company. If he does, his vote shall not be counted. This prohibition does not apply to any of the following matters, namely:
 - 112.1 a contract or arrangement for giving to the Director security or a guarantee or indemnity in respect of:
 - 112.1.1 money lent by him or obligations undertaken by him or by any other person at the request of or for the benefit of the Company or any of its subsidiaries; or
 - 112.1.2 a debt or obligation of the Company or any of its subsidiaries for which he himself has assumed responsibility in whole or part under a guarantee or indemnity or by the giving of security;
 - 112.1.3 where the Company or any of its subsidiary undertakings is offering securities in which offer the Director is, or may be, entitled to participate as a holder of securities or in the underwriting or subunderwriting of which the director is to participate;

112.1.6 concerning insurance which the Company proposes to maintain or purchase for the benefit of Directors or the benefit of persons including Directors.

112.2 A company shall be deemed to be a company in which a Director owns 1 per cent or more if and so long as he is (either directly or indirectly) the holder of or beneficially interested in 1 per cent or more of any class of its equity share capital or of the voting rights available to its members. For the purpose of this paragraph there shall be disregarded any shares held by a Director as bare or custodian trustee and in which he has no beneficial interest, any shares comprised in a trust in which the Director's interest is in reversion or remainder if and so long as some other person is entitled to receive the trust income, and any shares comprised in an authorised unit trust scheme in which the Director is interested only as a unit holder.

112.3 Where a company in which a Director owns 1 per cent or more is materially interested in a transaction, he shall also be deemed materially interested in the transaction.

112.4 If any question arises at any meeting of the Board as to the materiality of the interest of a Director or as to the entitlement of a Director (in each case, other than the chairman of the meeting) to vote or be counted in the quorum and the question is not resolved by his voluntarily agreeing to abstain from voting or not to be counted in the quorum, it shall be referred to the chairman of the meeting. His ruling shall be final and conclusive except in a case where the nature or extent of the interest of the Director concerned as known to the Director has not been fairly disclosed to the Board. If the question relates to the chairman of the meeting, it shall be decided by a resolution of the Board (for which purpose the chairman shall be counted in the quorum but may not vote). The resolution shall be final and conclusive except in a case where the nature or extent of the interest of the chairman as known to him has not been fairly disclosed to the Board.

Powers of directors

113 The business of the Company shall be managed by the Directors, who may exercise all such powers of the Company as are not by the Statutes or by these Articles required to be exercised by the Company in general meeting, but subject to any regulations of these Articles, to the provisions of the Statutes, and to such regulations, which are not inconsistent with those regulations or provisions, as may be prescribed by special resolution of the Company in general meeting. No regulation made by the Company in

general meeting shall invalidate any prior act of the Directors which would have been valid if the regulation had not been made. The general powers given by this article are not limited or restricted by any special authority or power given to the Directors by any other article.

- 114 The Directors may arrange that any branch of the business carried on by the Company or any other business in which the Company is interested shall be carried on by or through one or more subsidiaries. They may on behalf of the Company make such arrangements as they think advisable for taking the profits or bearing the losses of any branch or business or for financing, assisting or subsidising any subsidiary or guaranteeing its contracts, obligations or liabilities. They may appoint, remove and reappoint any person (whether a member of their own body or not) to act as a director, managing director or manager of a subsidiary or any other company in which the Company is interested, and may determine his remuneration (whether by way of salary, commission on profits or otherwise). A Director may retain any remuneration payable to him in respect of the appointment.
- 115 The Directors may by power of attorney appoint any person to be the attorney of the Company for such purposes and with such powers, authorities and discretions (not exceeding those vested in or exercisable by the Directors under these Articles) and for such period and subject to such conditions as they think fit. The power of attorney may contain such provisions for the protection and convenience of persons dealing with the attorney as the Directors think fit and may authorise the attorney to sub-delegate all or any of the powers, authorities and discretions vested in him.
- 116 The Directors may:
- 116.1 procure the establishment and maintenance of or participation in or contribution to any non-contributory or contributory pension or superannuation fund, scheme or arrangement or life assurance scheme or arrangement for the benefit of, and pay, provide for or procure the grant of donations, gratuities, pensions, allowances, bonuses, benefits or emoluments to, any person (including directors and other officers whether of the Company or of any other company referred to in this paragraph) who is or has been in the employment of the Company, or of any company which is a subsidiary of the Company or a predecessor in business of the Company or a subsidiary, or of any allied or associated companies of the Company or any such companies and the spouses, widows, widowers, families, dependants or connections of any such persons. No pension, annuity or other allowance or benefit (except as provided for by or in accordance with any other article) shall be granted to a Director or former Director who has not been an executive Director or held any other office or place of profit under the Company or any of its subsidiaries or to a person who has no claim on the Company except as a relation, connection or dependant of a Director or former Director, without the approval of an ordinary resolution of the Company.
- 116.2 establish, maintain and give effect to any scheme approved by an ordinary resolution for the allotment of or the grant of options to subscribe for shares of the Company to persons (including Directors) in the employment of the Company or any subsidiary of the

Company and may exercise all the powers conferred on them by the scheme (including any power to alter or add to its provisions). These Articles shall be deemed to be modified so far as may be necessary to give effect to the scheme in respect of any shares in issue or under option.

- 116.3 procure any of the matters referred to in this article are done by the Company either alone or in conjunction with any other company.
- 116.4 [change the name of the Company.](#)
- 116.5 [exercise any of the powers conferred by the Statutes to make provision for the benefit of any persons employed or formerly employed by the Company or any of its subsidiaries \(other than a director or former director or shadow director\) in connection with the cessation or the transfer to any person of the whole or part of the undertaking of the Company or any of its subsidiaries.](#)
- 117 All cheques, promissory notes, drafts, bills of exchange and other negotiable or transferable instruments, and all receipts for moneys paid to the Company, shall be signed, drawn, accepted, endorsed or otherwise executed in such manner as the Directors determine.

Directors' borrowing powers and restrictions on borrowing

118 In this article 118:

"Borrowings" means moneys borrowed, amounts raised pursuant to any note purchase facility, the issue of bonds, debentures, loan stock or any similar instrument where all such amounts shall be evaluated in accordance with generally accepted accounting principles and in the manner required for inclusion in liabilities in the consolidated group accounts;

"Cash and Cash Equivalents" means liquid investments that are readily convertible to known amounts of cash where all such amounts shall be evaluated in accordance with generally accepted accounting principles and in the manner required for inclusion in cash and cash equivalents in the consolidated group accounts;

"Group" means the Company and its Subsidiary Undertakings for the time being;

"Shareholders' Equity" means equity attributable to the owners of the Company; and

"Subsidiary Undertaking" means a subsidiary undertaking of the Company which is required by the Statutes to be included in consolidated group accounts.

- 118.1 Subject as hereinafter provided the Directors may exercise all the powers of the Company to borrow money, and to mortgage or charge its undertaking, property and assets (present and future) and uncalled capital, or any part thereof, and subject to the provisions of the Statutes to issue debentures, debenture stock, and other securities

whether outright or as security for any debt, liability or obligation of the Company or of any third party.

118.2 The Directors shall restrict the Borrowings of the Company and exercise all voting and other rights or powers of control exercisable by the Company in relation to its Subsidiary Undertakings (if any) so as to secure (so far, as regards Subsidiary Undertakings, as by such exercise they can secure) that the aggregate amount for the time being remaining outstanding of all Borrowings by the Group and for the time being owing to persons outside the Group net of Cash and Cash Equivalents shall not at any time, without the previous sanction of an ordinary resolution of the Company in general meeting, exceed a sum equal to the greater of:

118.2.1 £250,000,000; or

118.2.2 if positive, four times the total Shareholders' Equity as shown in the latest audited consolidated balance sheet of the Group.

118.3 For the purposes of this article 118 Borrowings shall not include and shall be deemed not to include amounts borrowed for the purpose of repaying the whole or any part (with or without premium) of any monies borrowed by any member of the Group then outstanding and so to be applied within six months of being so borrowed, pending their application for such purpose within such period.

118.4 A certificate or report by the Auditors as to the amount of the limit in article 118.2 or to the effect that the limit imposed by this article has not been or will not be exceeded at any particular time or times or during any period shall be conclusive evidence of such amount or fact for the purposes of this article.

118.5 No lender or other person dealing with the Company or any of its Subsidiary Undertakings shall be concerned to see or enquire whether the said limit is observed, and no debt incurred or security given in excess of such limit shall be invalid or ineffectual, except in the case of express notice to the lender or the recipient of the security at the time when the debt was incurred or security given that the said limit has been or would thereby be exceeded.

Executive directors

119 The Directors may appoint one or more of their number to an executive office including the office of chairman, vice-chairman, managing Director, joint managing Director, assistant managing Director or manager or any other salaried office for such period and on such terms as they think fit. Without prejudice to any claim a Director may have for damages for breach of any contract of service between him and the Company, his appointment shall automatically ~~terminate~~ if he ceases from any cause to be a Director, or (subject to the terms of any contract between him and the Company) if the Directors resolve that his term of office as an executive Director should be ~~terminated~~.

120 A Director holding office pursuant to the last preceding article shall receive such

- 121 The Directors may entrust to and confer upon a Director holding executive office any of the powers exercisable by them as Directors upon such terms and conditions and with such restrictions as they think fit, and either collaterally with or to the exclusion of their own powers, and may revoke, withdraw or vary any of the powers.

Rotation of directors

- 122 At every annual general meeting any Directors who are bound to retire under article 128 and one-third of the other Directors or, if their number is not a multiple of three, then the number nearest to but not exceeding one-third shall retire from office. A Director retiring at a meeting shall retain office until the close of the meeting.

- 123 The Directors to retire on each occasion shall be those who have been longest in office since their last election but, as between persons who became or were re-elected Directors on the same day, those to retire shall (unless they otherwise agree among themselves) be determined by lot. The Directors to retire on each occasion (both as to number and identity) shall be determined by the composition of the Board at the date of the notice convening the annual general meeting. No Director shall be required to retire or be relieved from retiring by reason of any change in the number or identity of the Directors after the date of the notice but before the close of the meeting.

- 124 A retiring Director shall be eligible for re-election.

- 125 Subject to the provisions of these Articles, the Company at the meeting at which a Director retires may elect a person to fill the vacated office. In default, the retiring Director shall, if willing to continue to act, be deemed to have been re-elected, unless at the meeting it is expressly resolved not to fill the vacated office or unless a resolution for the re-election of the Director has been put to the meeting and lost.

- 126 No person other than a Director retiring at the meeting shall, unless recommended by the Directors, be eligible for election to the office of Director at any general meeting, unless not less than 7 nor more than 42 days before the date appointed for the meeting there has been left at the Office a notice In Writing, signed by a member (not being the person to be proposed) duly qualified to attend and vote at the meeting, of his intention to propose the person for election, and a notice In Writing signed by that person of his willingness to be elected.

- 127 The Company in general meeting may increase or reduce the number of Directors and may determine in what rotation the increased or reduced number is to go out of office.

- 128 The Directors may appoint any person to be a Director, either to fill a casual vacancy or

as an addition to the existing Board, but so that the total number of Directors does not exceed the maximum number fixed by or in accordance with these Articles. The Director shall hold office only until the next following annual general meeting and shall then be eligible for re-election. A Director who retires under this article shall not be taken into account in determining the Directors who are to retire by rotation at the meeting.

- 129 The Company may, by ordinary resolution of which special notice has been given in accordance with section 312 CA 2006, remove any Director (including a managing Director or other executive Director, but without prejudice to any claim for damages under any contract) before the expiration of his period of office and may by an ordinary resolution appoint another person in his place. The person who is appointed shall be subject to retirement at the same time as if he had become a Director on the day on which the Director in whose place he is appointed was last elected a Director.

Proceedings of directors

- 130 The Directors may meet together for the despatch of business, adjourn and otherwise regulate their meetings as they think fit. Questions arising at any meeting shall be determined by a majority of votes and in case of an equality of votes the chairman shall have a second or casting vote. A Director may at any time, and the Secretary on the requisition of a Director shall, summon a Board meeting.

- 131 Notice of a Board meeting may be given to a Director personally or by word of mouth or sent In Writing to him at his last known address or any other address given by him to the Company for this purpose or sent an Electronic Form to such address (if any) for the time being specified by him or on his behalf to the Company for that purpose. A Director may waive notice of a meeting either prospectively or retrospectively. A Director absent or intending to be absent from the United Kingdom may request the Directors that notices of meetings of the Directors shall during his absence be sent in writing to him to such address given by him to the Company for this purpose, whether or not out of the United Kingdom, or be sent by Electronic Means to such address (if any) for the time being notified by him to the Company for that purpose. If no such request is made to the Directors, it shall not be necessary to send notice of a meeting of the Directors to any Director who is for the time being absent from the United Kingdom.

- 132 The quorum necessary for the transaction of the business of the Directors may be fixed by the Directors and, unless fixed at any other number, shall be two save that where all the Directors other than one Director (“**the Non-Conflicted Director**”) are precluded from forming part of the quorum pursuant to article 102 or, if all the Directors other than one Director are not precluded from forming part of the quorum pursuant to article 112 but nevertheless choose to abstain from voting on a matter because of a conflict of interests or potential conflict of interests not covered by article 102 then the quorum necessary for the transaction of the business of the Directors shall be one Director provided that it is the Non-Conflicted Director.

- 133 The continuing Directors or a sole continuing Director may act notwithstanding any vacancies in the Board. If and so long as the number of Directors is reduced below the

minimum number fixed by or in accordance with these Articles, the continuing Directors or Director may act for the purpose of filling vacancies in the Board or of summoning general meetings of the Company, but not for any other purpose. If there are no Directors or no Director able or willing to act, any two members may summon a general meeting of members for the purpose of appointing Directors.

134 If the Directors have not appointed a chairman or vice-chairman pursuant to article 119, or if at any meeting neither the chairman nor the vice-chairman is present within 5 minutes after the time appointed for holding it, the Directors present may choose one of their number to be chairman of the meeting.

135 The Board may establish local boards or agencies for managing any of the affairs of the Company, either in the United Kingdom or elsewhere, and may appoint any persons to be members of the local boards, or to be managers or agents, and may fix their remuneration. The Board may delegate to any local board, manager or agent any of the powers, authorities and discretions vested in or exercisable by the Board (other than the power to borrow and make calls), with power to sub-delegate, and may authorise the members of any local board or any of them to fill any vacancies and to act notwithstanding vacancies. An appointment or delegation may be made upon such terms and subject to such conditions as the Board thinks fit. The Board may remove any person appointed as above and may revoke or vary any delegation, but a person dealing in good faith and without notice of the revocation or variation shall not be affected by it.

136 A meeting of the Directors at which a quorum is present shall be competent to exercise all powers and discretions exercisable by the Directors.

137 The Directors may delegate any of their powers to committees consisting of such number of members of their body as they think fit and may revoke a delegation and discharge a committee in whole or in part. A committee shall in the exercise of the powers delegated to it conform to any regulations that are imposed by the Directors.

138 The meetings and proceedings of a committee consisting of two or more members shall be governed by the provisions of these Articles regulating the meetings and proceedings of the Directors, so far as they are applicable and are not superseded by any regulations made by the Directors under the last preceding article.

139 A member of the Board, or of a committee of the Board, may participate in a meeting of the Board or the committee by means of a conference telephone or any communication equipment which allows all persons participating in the meeting to hear each other. A participant shall be deemed to be present in person at the meeting and shall be entitled to vote or be counted in a quorum accordingly. The meeting shall be deemed to take place where the largest group of those participating is assembled or, if there is no such group, where the chairman of the meeting then is.

140 A resolution in writing, signed or otherwise agreed to by all those Directors for the time being entitled to receive notice of a meeting of the Directors or by all the members of a committee for the time being entitled to receive notice of a committee meeting, (in each

case) who would have been entitled to vote on the resolution at a meeting of the Directors or of such committee shall be as valid and effective for all purposes as a resolution passed at a meeting duly convened and held, and may consist of two or more documents in like form each signed or agreed to by one or more of such Directors or members of such committee, provided that all those signing or agreeing to the resolution would have formed a quorum at such a meeting. Such a resolution in writing need not be signed or agreed to by an alternate Director if it is signed or agreed to by the Director who appointed him.

141 The Directors shall cause minutes to be made in books provided for the purpose:

141.1 of all appointments of officers made by the Directors;

The minutes, if purporting to be signed by the chairman of the meeting at which the appointments were made, or the Directors were present, or the resolutions were passed or proceedings held (as the case may be), or by the chairman of the next succeeding meeting of the Company, or class of members of the Company, or Directors or committee (as the case may be), shall be sufficient evidence without any further proof of the facts stated in it.

142 All actions done by any Board meeting, or meeting of a committee of Directors, or by a person acting as a Director, shall as regards all persons dealing in good faith with the Company, notwithstanding that there was some defect in the appointment of any Director, or of the person acting as a Director, or that they or any of them were disqualified, or had vacated office or were not entitled to vote, be as valid as if each of them had been duly appointed, and was qualified and had continued to be a Director and had been entitled to vote.

143 The Directors may appoint any person to an office or employment having a title including the word "director" or attach such a title to any existing employment with the Company and may terminate the appointment or the use of the title. The inclusion of the word "director" in the title of any office or employment (other than the office of managing or joint managing or deputy or assistant managing director) does not imply that the employee is a Director and the employee shall not as a result be empowered in any respect to act as a Director or be deemed to be a Director for any of the purposes of these Articles.

Secretary

144 The Secretary shall be appointed by the Directors at such remuneration and upon such terms as they think fit. The Secretary may be removed by the Directors. The Directors may appoint an assistant Secretary or assistant Secretaries and temporary substitutes for

the Secretary. An assistant Secretary or temporary substitute shall for the purpose of these Articles be deemed to be and may fulfil the duty of the Secretary subject to any limitation prescribed by the Directors.

- 145 A provision of the Statutes or these Articles requiring or authorising a thing to be done by or to a Director and the Secretary shall not be satisfied by its being done by or to the same person acting both as Director and as, or in the place of, the Secretary.

The seal

- 146 The Seal shall be used only by the authority of the Directors or of a committee of Directors authorised by the Directors. The Directors may determine who shall sign any instrument to which the Seal is affixed.

- 147 A document signed by a Director and by the Secretary or another Director or a Director in the presence of a witness and expressed, in whatever form of words, to be executed by the Company shall have the same effect as if it were under seal. A document executed in this way which makes it clear on its face that it is intended to be a deed, in whatever form of words, has effect, upon delivery, as a deed.

Where any books, records, documents or accounts are elsewhere than at the Company's head office, the local manager or other officer of the Company having the custody of them shall be deemed to be a person appointed by the Directors under this article.

The Company in general meeting may declare dividends accordingly. No dividend or interim dividend may be paid otherwise than in accordance with Part 23 CA 2006.

Pending application the sum reserved may either be employed in the business of the Company or be invested in such investments (other than shares of the Company) as the Directors think fit. Purchase of own shares

Subject to, and in accordance with, the provisions of the Statutes and subject to articles 53 and 54, the Company may purchase its own shares (including any redeemable shares and the "B" Deferred Shares).

The Company may not purchase its own shares if at the time of purchase there are outstanding any convertible securities of the Company, unless either there are provisions in the relevant trust deed or terms of issue permitting the purchase or the purchase has been sanctioned by a special resolution passed at a separate class meeting of the holders of the convertible securities.
